Information and application for non-FedUni students who wish to enrol in course/s as part of a cross-institutional program at FedUni.

What is Cross-Instutional Program

A cross-institutional program is a program of study comprising course(s) being undertaken with one provider (the host providers – Federation University) as part of a program for which you are enrolled with another provider (the home provider. Eg – Deakin University). If you are currently enrolled in a degree at another recognised Higher Education Provider, you may apply to study single courses at Federation University on a cross-institutional inbound basis.

Application Closing Date

The attached Application for cross-institutional study (inbound) must be submitted to the relevant FedUni school no later than week two of the relevant semester. You will receive written notification of the outcome of your application once it has been processed.

Course Available

You can select from a wide range of courses which are subject to available places. Enrolment is determined on a semester-by-semester basis and no guarantee of subsequent enrolment can be made. In addition, FedUni may not admit cross-institutional students where insufficient places are available for its own students.

Prerequisites

It is your responsibility to ensure that you meet the requirements for entry into the course/s.

Fees for Commonwealth Supported Students

The student contribution amount is assessed by the host provider (FedUni) and may not necessarily be equal to the student contribution amount that would have been incurred had the course of study been undertaken at your home provider. You are required to complete and submit a Request for Commonwealth assistance and HECS-HELP form (available from Student Administration) in conjunction with this application. For further information on fees at FedUni, please refer to federation.edu.au/fees.

Withdrawal

If you wish to withdraw from the course/s in which you are enrolled as a crossinstitutional student, you must complete a Withdrawal from All Studies form (available from Student Administration). This form must be submitted to Student Administration before the relevant census date to avoid financial liability or academic penalty. You must also notify your home provider course card.
